**ORDER AND FINAL JUDGMENT GRANTING DIRECT PURCHASER PLAINTIFFS’
UNCONTESTED MOTION FOR FINAL APPROVAL OF THE SETTLEMENT WITH
DEFENDANTS CARGILL, INC. AND CARGILL MEAT SOLUTIONS CORPORATION**

This Court held a Fairness Hearing on Direct Purchaser Plaintiffs’ Motion for Final Approval of the Settlement with Defendants Cargill, Incorporated and Cargill Meat Solutions Corporation and First Distribution of Net Settlement Proceeds (“Motion”) on June 18, 2025, as well as a hearing on the Final Approval motion on July 29, 2025, during which the Court discussed its rationale and its findings which underlie its decision to grant the Motion. The Court, having reviewed the Motion, its accompanying memorandum, declarations and the exhibits thereto, the Settlement Agreement, and all papers filed, hereby **ORDERS AND ADJUDGES:**

1. The Court has jurisdiction over the subject matter of this Action and each of the parties to the Settlement Agreement (ECF No. 1100-1), including all members of the Settlement Class (also referred to herein as the “Class”) and Cargill, Incorporated and Cargill Meat Solutions (collectively, “Cargill”).

2. For the purposes of this Order, except as otherwise set forth herein, the Court adopts and incorporates the definitions contained in the Settlement Agreement.

3. The Court affirms the appointment of Lockridge Grindal Nauen PLLP and Hagens Berman Sobol Shapiro LLP as Co-Lead Counsel for the Settlement Class pursuant to Federal Rule

of Civil Procedure 23(g). *See* Order Preliminarily Approving Settlement with Cargill (ECF No. 1128) (“Preliminary Approval Order”) § 7. The Court appoints John Gross and Company, Inc. and Maplevale Farms, Inc. as class representatives for the Settlement Class.

4. Pursuant to Rule 23 of the Federal Rules of Civil Procedure, the Court affirms that the following Settlement Class has been certified solely for the purposes of the Settlement:

All persons and entities who directly purchased Turkey from any Defendant or alleged co-conspirator in the United States at any time during the Settlement Class Period. Specifically excluded from the Settlement Class are Defendants and any alleged co-conspirators identified in the Action; the officers, directors or employees of any Defendant or alleged co-conspirator; any entity in which any Defendant or alleged co-conspirator has a controlling interest; and any affiliate, legal representative, heir or assign of any Defendant or alleged co-conspirator. Also excluded from the Settlement Class are any federal, state or local governmental entities, any judicial officer presiding over the Action and the members of his/her immediate family and judicial staff, and any juror assigned to the Action.

Preliminary Approval Order at § 3. The Settlement Class Period is January 1, 2010, through January 1, 2017. *Id.* at § 5.

5. The Court finds that, for Settlement purposes, the Settlement Class meets the requirements of Rule 23(a) and Rule 23(b)(3) of the Federal Rules of Civil Procedure. As to the requirements of Rule 23(a), the Court expressly finds that (1) the Settlement Class certified herein numbers thousands of entities, and joinder of all such entities would be impracticable; (2) there are questions of law and fact common to the Settlement Class; (3) Plaintiffs’ claims are typical of the claims of the Settlement Class they seek to represent for purposes of settlement; and (4) Plaintiffs are adequate representatives of the Settlement Class. As to the requirements of Rule 23(b)(3), the Court expressly finds that the questions of law and fact common to the Settlement Class predominate over any questions affecting any individual Settlement Class member, and that a class action on behalf of the Settlement Class is superior to other available means of adjudicating this dispute.

6. The Court hereby **GRANTS** final approval of the Settlement Agreement and its terms and finds that the Settlement is, in all respects, fair, reasonable, and adequate pursuant to Federal Rule of Civil Procedure 23. Further, the Court directs consummation of the Settlement Agreement according to its terms and conditions.

7. This Court hereby dismisses on the merits and with prejudice all claims in the DPP action against Cargill, with each party to bear its own costs and fees, including attorneys' fees, except as provided in the Settlement Agreement and in DPPs' Motion for Interim Payment of Attorneys' Fees, Reimbursement of Litigation Expenses, and Class Representative Service Awards (ECF Nos. 1223-1225).

8. The releases set forth in Paragraphs 16 and 17 of the Settlement Agreement are incorporated herein and the Releasing Parties shall, by operation of law, be deemed to have released all Cargill Released Parties from the Released Claims. All entities who are Releasing Parties or who purport to assert claims on behalf the Releasing Parties are hereby and forever barred and enjoined from commencing, prosecuting, or continuing, against the Cargill Released Parties, in this or any other jurisdiction, any and all claims, causes of action or lawsuits, which they had, have, or in the future may have arising out of or related to any of the Released Claims as defined in the Settlement Agreement.

9. The Cargill Released Parties are hereby and forever released and discharged with respect to any and all claims or causes of action which the Releasing Parties had, have, or in the future may have, arising out of or related to any of the Released Claims as defined in the Settlement Agreement.

10. The notice given to the Settlement Class, including individual notice to all members of the Settlement Class who could be identified through reasonable efforts, was the most effective

and practicable under the circumstances. This notice provided due and sufficient notice of proceedings and of the matters set forth therein, including the proposed Settlement and the proposed claims process, to all persons entitled to such notice, and this notice fully satisfied the requirements of Rules 23(c)(2) and 23(e)(1) of the Federal Rules of Civil Procedure and the requirements of due process.

11. No objections to the Settlement or to DPPs' currently pending Motion for Interim Payment of Attorneys' Fees, Reimbursement of Litigation Expenses, and Class Representative Service Awards (*see* ECF Nos. 1223-1225) have been filed.

12. As set forth in the notice to the Settlement Class, DPPs' pending Motion for Interim Payment of Attorney's Fees, Reimbursement of Litigation Expenses, and Service Awards filed on April 7, 2025 (*see* ECF Nos. 1223-1225) shall be decided separately from this Order.

13. Any member of the Settlement Class who failed to timely and validly request to be excluded from the Settlement Class shall be subject to and bound by the provisions of the Settlement Agreements, the Released Claims contained therein, and this Order with respect to all Released Claims, regardless of whether such members of the Settlement Class seek or obtain any distribution from the Settlement proceeds. Persons or entities who timely and validly requested to be excluded from the Settlement Class are listed in **Exhibit A** attached hereto. Such persons or entities are not entitled to any recovery from the Settlement proceeds. Furthermore, nothing in this Order shall be construed as a determination by this Court that any person or entity satisfies the criteria for membership in the Settlement Class merely because it filed a Request for Exclusion.

14. A list of person or entities requesting to be excluded from the Settlement Class who have partial assignments ("Partial Assignees") is set forth in the attached **Exhibit B**. For each such partial assignment for which exclusion from the Settlement Class has been requested by the Partial

Assignee, all information provided to the Settlement Administrator by the Partial Assignee that identifies the assignor, the assignee, and the total value of direct Turkey purchases during the Class Period from each Defendant or co-conspirator that is subject to the assignment has been assembled by the Settlement Administrator and provided to the parties. Claims based on purchases assigned by the Settlement Class member identified as Assignor on the attached Exhibit B to the Partial Assignee are excluded from the Settlement Class. Except for the claims of the Partial Assignees, all claims belonging to the Settlement Class members (whether assigned or not) are part of the Settlement Class and released through the provisions of the Settlement Agreement and this Order.


15. Without affecting the finality of this Final Judgment in any way, the Court hereby retains continuing exclusive jurisdiction over: (a) consummation, administration, and implementation of the Settlement Agreement and any allocation or distribution to Settlement Class members pursuant to further orders from this Court; (b) disposition of the Settlement proceeds; (c) hearing and determining applications by Co-Lead Counsel for attorneys' fees, costs, expenses, and interest; (d) the actions in this litigation until this Final Judgment has become effective and each and every act agreed to be performed by the parties all have been performed pursuant to the Settlement Agreement; (e) hearing and ruling on any matters relating to any plan of allocation or distribution of proceeds from the Settlement; (f) the parties to the Settlement Agreement for the purpose of enforcing and administering the Settlement Agreement and the releases contemplated by, or executed in connection with, the Settlement Agreement; (g) the enforcement of this Final Judgment; and (h) over any suit, action, proceeding, or dispute arising out of relating to the Settlement Agreement or the applicability of the Settlement Agreement that cannot be resolved by negotiation and agreement.

16. Cargill has served upon the appropriate state officials and the appropriate federal official notice under the Class Action Fairness Act, 28 U.S.C. § 1715.

17. The Court finds, pursuant to Rules 54(a) and (b) of the Federal Rules of Civil Procedure, that judgment should be entered and further finds that there is no just reason for delay in the entry of final judgment as to the parties to the Settlement Agreements. Accordingly, the Clerk is hereby direct to enter this Order and Final Judgment forthwith.

IT IS SO ORDERED.
